

## **RULES AND REGULATIONS**

**ENTRIES** - Entries close for Greenfield's Spring Classic May 13th and Greenfield's Summer Classic June 3rd. A post entry fee of \$25.00 per horse will be applied after the closing date. All entry forms should be filled out completely and emailed back to greenfieldseriesclassics@gmail.com or mail to 2465 Woodington Way Suamico, WI 54173. No numbers will be given until the entry is complete and final payment has been made or an open check/credit card has been left on file in the show office. **NO STALLS WILL BE RESERVED WITHOUT PAYMENT.** 

ENTRY PAYMENT - Please make checks payable to Northstar Equestrian LLC

**OFFICE HOURS** - The office will be open one hour prior to the start time each day

**TRAILER-INS** - will be assessed a grounds fee of \$50.00 per day per horse

**STABLING** - \$125.00 Please make your reservations by contacting Bethany Parins at 920-360-4862 or email greenfieldseriesclassics@gmail.com. Trailer ins welcome for \$50 per day per horse. Bedding available for \$8.00 per bag. Stalls are limited. Horses can arrive after noon on Thursday. **NO STALLS WILL BE RESERVED WITHOUT PAYMENT.** 

**GROOMING/TACK STALLS** - Tack and grooming stalls will be available once all entries are in and ONLY if stalls are available.

**SCRATCHES/NO SHOWS -** All scratches must be done in the horse show office or online. Once the classes have begun NO REFUNDS will be given.

**NO ADDS WILL BE ACCEPTED ON SHOW DAY** - All entries must be done by 4pm the previous day!

**TRAINER SPLITS** – Northstar Equestrian LLC will allow trainer splits for the purchase of tack stalls, shavings, etc. to be applied to the clients horse show bill. Trainer splits are due in the horse show office by noon on Saturday for the weekend show. Please let your clients know if they should expect splits on their bill. Any splits that are unaccounted for or uncollected by the client will revert to the trainer for payment.

**NUMBERS** – A number will be assigned to each horse and must be visible on the riders back or saddle pad when in the show ring.

#### **GENERAL RULES -**

Every class herein, which is covered by the rules and specifications of the current WHJA rulebook will be conducted and judged in accordance therewith. The horse show management reserves the right to itself to refuse, limit, accept conditionally, or to cancel any entries, disqualify any riders or exhibitors thereby canceling awarded prizes, to change any course, to cancel or combine any unfilled classes or to change rings or officials, to reschedule classes after due notice to exhibitors, to change specifications in jumper classes as competition warrants and to intercept all questions and conditions in regards to, or arising out of, or incident to the show without claims for damages or recourse of any kind. All entry blanks must bear signature. Exhibitors are responsible for their own errors and omissions.

**WISCONSIN EQUINE ACT** - Warning under the Equine Activity Liability Act, each participant who engages in an equine activity expressly assumes the risk of engaging in and legal responsibility for injury, loss or damage to person or property resulting from the risk of Equine activities.

COGGINS/VACCINATIONS – EFFECTIVE JANUARY 1, 2005 – All Wisconsin equine (Horses, Ponies, Mules, etc.) 12 months old and older participating in an advertised equine event ("Advertised equine event" means a show, rodeo, exhibition, trail ride or horse fair, excluding sales or actions, that is posted or media promoted) must be accompanied by a negative test for equine infectious anemia/ E.I.A. (coggins/CELISA) conducted within the previous 12 months. A health certificate is NOT required for WISCONSIN EQUINES.

Horses must also provide Proof of Vaccinations within 6 months (180 days)- Equine Influenza Virus and Equine Herpes Virus (Rhino-pneumonitis) prior to entering the stables.

#### **SCHOOLING-**

**USEF RULES AND REGULATIONS** will apply to both hunters and jumpers during all schooling on the show grounds

**PETS** - Dogs must be on a leash at all times. Unrestrained dogs create a serious safety hazard to exhibitors and their horses.

All owners and exhibitors shall be held responsible for any damage incurred to stalls, buildings and other property and shall be billed accordingly.

**PROTECTIVE HEADGEAR -** ALL EXHIBITORS ARE REQUIRED TO WEAR PROPERLY FITTING ATSM PROTECTIVE HEADGEAR WHEN JUMPING ON THE SHOW GROUNDS. Additionally, all juniors must wear properly fitted headgear with harness secured while mounted anywhere on show grounds. Failure to comply will result in an entry being disqualified with NO REFUND.

**MOTORIZED VEHICLES -** Only those with a valid driver's license will be allowed to drive motorized vehicles on the horse show grounds. Anyone in violation will be asked to leave.

\* Drinking alcoholic beverages and riding will not be permitted.

**MEDICAL WASTE** - Sharps MUST be placed on the proper receptacles. RED sharps containers will be placed in the entry of all barns.

THIS SHALL BE THE CONDITION OF ENTRY TO THIS HORSE SHOW AND SHOW GROUNDS.

**DAMAGE** - All owners and exhibitors shall be held responsible for any damage incurred by them, their agents or employees to stalls, buildings and other properties on the show grounds and will be billed accordingly for any such damage.

**AWARDS & RIBBONS -** An award and 6 ribbons will be awarded in each class. Prize money will be awarded 1st -6th place.

**REFUNDS -** A NON-REFUNDABLE deposit of \$125.00 is required at the time of entry to reserve stalls. THIS WILL NOT BE REFUNDED UNDER ANY CIRCUMSTANCES. Any additional funds paid before the event may be refunded at the discretion of horse show management. Those seeking a refund must notify horse show management prior to show. If eligible for a refund, a check for the amount of the refund less a \$25.00 office fee will be mailed within 30 days of the Greenfield Summer Classis show. No refunds will be considered after show starts.

## **USHJA OUTREACH PROGRAM**

The USHJA Outreach Program has been established to engage and connect hunter and jumper riders and horse owners with the USHJA by providing the opportunity to participate in USHJA branded classes and competitions, to earn points toward year-end rewards and awards, and to earn the chance to participate in the prestigious USHJA National Championships.

Competitors with a USHJA membership (Outreach level or higher) will be eligible to earn yearend awards in their section(s).

USHJA members (Outreach level or higher) can earn Certificates of Merit throughout the year. Once a rider earns at least 50-74 points during the competition year, that competitor will receive a Bronze Level Certificate of Merit, at 75-99 points a Silver Level Certificate of Merit, and at 100 points a Gold Level Certificate of Merit. Riders achieving Bronze, Silver or Gold point level will be eligible to redeem their points at year-end for items on their choice: USHJA logo wear, Bronze, Silver or Gold outreach ribbons or Outreach Medallions.

Outreach competitions may be hosted by any organizations meeting the minimum criteria, whether USEF-rated or local. unrecognized competitions.

Any rider may compete in Outreach hunter and jumper classes, bur riders wishing to earn points and national recognition, must be USHJA members. USHJA offers a free Outreach Membership. Horses are not required to be registered with USHJA to compete in Outreach classes.

## USHJA OUTREACH MEMBERSHIP REQUIREMENTS

A. The Outreach Membership is free. All outreach class participants must join as a USHJA Outreach member to be eligible for awards

B. For show official membership requirements, refer to Category 1 and category 2 specific requirements

C. Horses are not required to be registered with USHJA or be microchipped to compete in Outreach classes.

#### **Hunter Sections**

- 1. All courses must have at least seven jumps and no combinations are allowed. Oxers are discouraged for any class with fences below 2'6". Each height may be offered as Open; Junior; Amateur; Pony; split or combined at managers discretion. At one day USHJA Outreach shows, only the first two numbered over fences classes (hunters), regardless of how many classes are held, and one hunter under saddle class in each hunter section will count for the USHJA Outreach points. At multiple day USHJA Outreach Shows, only the first three numbered over fences classes, regardless of how many classes are held, and one under saddle class in each hunter section will count for USHJA Outreach.

## **USHJA OUTREACH CLASS SECTIONS & POINTS**

#### **Equitation Sections**

- 1. All courses must have at least seven jumps and no combinations are allowed. Oxers are discouraged for any class with fences below 2'6". Each height may be offered as Open; Junior; Amateur; Pony; split or combined at managers discretion. At one day USHJA Outreach Shows, only the first two numbered over fences classes, regardless of how many classes are held, and one equitation flat class in each equitation section will count for USHJA Outreach points. At multiple day USHJA Outreach Shows, only the first three numbered over fences classes, regardless of how many classes are held, and one flat class in each equitation section will count for USHJA Outreach points. Riders must be juniors or amateurs.

### **Jumper Sections**

- 1. All courses must have at least seven jumps and no combinations are allowed. Oxers are discouraged for any class with fences below .75m. At one day USHJA Outreach Shows, only the first three numbered jumper classes in each section will count for USHJA Outreach points. At multiple day USHJA Outreach Shows, minimum of three classes and a maximum of five classes will count for USHJA Outreach Points. Show organizers are encouraged to use USEF Jumper Table IV, Sections 1 or 2 (Optimum Time) for scoring USHJA Outreach Jumper classes. The only other tables allowed are Table II, Section 2, a,b,c, or d, and Table II, Section 1. No other USEF Jumper scoring tables are allowed.

## USHJA OUTREACH CLASS SECTIONS & POINTS

Points will be accumulated according to Zone, within the Competition Year dating December 1st to November 30th of the following year.

#### Rider, horse and trainer requirements:

- 1. Horses competing in the USHJA Outreach Program will accrue points only if they are registered with USHJA.
- 2. Participation as a rider or as the owner of a horse will be tracked based on place of residence within a USHJA Zone.
- 3. A rider's home USHJA Zone will be determined by their place of residence during the current competition year (December 1 November 30). If a rider changes Zones, because of school, work, or other, rider must request permission change his home Zone in writing to the USHJA for competition points to follow the rider from one Zone to the next.
- 4. A Junior Rider has not reached his/her 18th birthday as of December 1st of the previous year.
- 5. An Adult Amateur is no longer eligible as a Junior Rider and is an Amateur according to USEF Rules (GR128).

#### Rider:

- 1. Riders must be an Outreach member (or higher) on or before the first day of competition to accrue rider points. Membership is free.
- 2. Points awarded:

1st place – 10 points
2nd place – 6 points
3rd place – 4 points
4th place – 2 points
5th place – 1 point
6th place – ½ point
```

#### Horse:

Horses must be registered with USHJA for points to be tracked. Otherwise, horses are not
required to be registered with USHJA or be microchipped to compete in USHJA Outreach
classes. Horse Registration is \$20 for an Annual Recording, or \$75 for a Lifetime Recording.

#### Points awarded:

#### Trainer:

Trainers of riders participating in the USHJA Outreach Program wishing to be recognized for yearend awards and recognition must be a USHJA Outreach member or higher on or before the first day of competition. Outreach Membership is free

## Outreach Program Rewards and Awards

Rewards and awards are based on rider or horse participation across any USHJA Outreach classes. A rider or a horse may accumulate points throughout any or all of the classes, allowing for participation across the many facets of the hunter, jumper and equitation competitions.

#### **Rewards:**

- 1. Rewards will be given by USHJA Zone.
- 2. Rewards for competing in any USHJA Outreach Class (Hunter, Equitation, Jumper) will be based on total points earned as follows:

Bronze Level: riders or horses must earn at least 50-74 points during the competition year. Silver Level: riders or horses must earn at least 75-99 points during the competition year. Gold Level: riders or horses must earn at least 100 points during the competition year.

Riders: Riders achieving a Bronze, Silver, or Gold point level will be eligible to redeem their points at year-end for items of their choice: USHJA logo wear, Bronze, Silver, or Gold Outreach ribbons or Outreach medallions.

Horses: Owners of horses achieving a Bronze, Silver, or Gold point level will be eligible to redeem their points at year-end for items of their choice: USHJA logo wear, Bronze, Silver or Gold Outreach stall plates or ribbons.

#### Awards:

**Trainers:** Outreach Trainers will be recognized by USHJA Zone for year-end awards. At year- end the trainer with the highest cumulative total earned USHJA Outreach Class points associated with Outreach members they train will be recognized as the USHJA Outreach Class High Point Trainer, and with a minimum of 100 points earned during the competition year will be awarded a USHJA Zone Outreach Program High Point Trainer jacket.

**Riders:** The rider achieving Gold Level status with the highest number of points from each Zone by October 15th will be awarded the "Golden Back Stage Pass", which includes an opportunity to attend the USHJA National Championships. These riders will be invited to participate in the Grand Prix Show Jumping and Hunter Derby course walks, participate in educational sessions, and be given the opportunity to compete at the USHJA National Championships in the Affiliate Championship sections.

**Horses:** Registered horses will have their Outreach points tracked and ranked within the USHJA Zone. Results will be displayed on the USHJA website.

## **Hunter Divisions**

**WARM UPS** – Open to any horse or pony. Horse can only be in this class once in a day and the rider must ride horse in the Warm up before a class. Warm up will be open all day. RIDER MUST INFORM GATE PERSON PRIOR TO ENTERING THE RING that the first round will be for the Warm up class. Height will be adjusted for class. Show Management reserves the right to cancel the Warm Up due to time constraints.

May only cross enter into the Ground Rail Equitation. No bending lines and no in-and-outs.
